Animals may remain in facility during application, but Adult Fly Concentrate is designed for treatment of facilities and premises – do not apply directly to animals, food, or feed crops. Dilute at the rate of 1-8 oz per gallon (1 gallon of the concentrate can be added to 16-120 gallons of water), using the high concentration for severe infestations and low concentration for maintenance applications. **Method of Application:** In compressed air or powered backpack, hand-held, or other sprayers, apply at 0.5-1.5 gallon of the diluted solution per 1000 sq. ft. In mister or fogger systems, apply at 0.2 gallon/1000 cu. ft. Apply as needed to control adult fly population. Reapply as often as needed.

STORAGE AND DISPOSAL Do not contaminate water, food, or feed by storage or disposal. Store in original container at room temperature

in a dry location inaccessible to children or animals. Keep container tightly closed. Do not reuse container. Rinse empty container and recycle or dispose in trash. Comply with state and local guidelines for disposal of unused product.
