DIRECTIONS FOR USE

Sprinkle as needed on ground or in bedding areas. Application rate may vary based on location treated, but a typical rate is 0.5 oz. per square foot.

For pests on animals such as mites on birds, apply at about 0.5 oz. (1-2 tablespoons) per 10 pounds body weight. Avoid face and eyes, applying dust where pests are heaviest, ruffling into feathers or fur to help penetrate and contact pests. Repeat as necessary.
