DIRECTIONS FOR USE

READ ENTIRE LABEL — USE IN ACCORDANCE WITH LABEL INSTRUCTIONS

Use Sites: Animal production facilities

Dilution: MIX CONTENTS WELL BEFORE USING. Dilute Pertinent Ag Crawling Insect Concentrate at a rate of 16-32 fluid ounces concentrate to 1 gallon with water (e.g. one 2-gallon jug of Crawling Insect Concentrate will make approximately 8-16 gallons of spray). Pour ½ of water into spray reservoir, add concentrate, then rinse empty concentrate jugs with remaining water and add to reservoir. Turn on agitator in spray tank if so equipped.

Application: Apply with a backpack or vehicle mounted sprayer with appropriate spray pattern and medium nozzle.

For use against litter beetles: Apply Pertinent Ag Crawling Insect Concentrate immediately before feed lines are placed, and after any litter replacement, decaking, or application of other litter treatment products. Apply Pertinent Ag Crawling Insect Concentrate at a rate of 2 gallons of diluted product per 1,000 sq. ft. treated area. Apply around the perimeter of the house for a band of 2-3 ft on the litter next to the walls and 1-2 feet up the wall. Apply a band of treatment 1-2 feet wide under feeders and water lines.

For use against cockroaches and bed bugs: Spray diluted Pertinent Ag Crawling Insect Concentrate in areas where insects congregate, such as in cracks, crevices, and crannies around production house - under and behind tables, in crevices around or between wall joists, around floor perimeter and at junctions between walls and ceiling. Apply at a rate of 2 gallons of diluted product per 1,000 sq. ft. of treated area.

PRECAUTIONARY STATEMENTS: Keep away from heat, sparks, open flames, and hot surfaces. Keep container tightly closed. Ground or bond container and receiving equipment. Use explosion-proof electrical, ventilating, or lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Do not breathe mist, vapors, or spray. Wash thoroughly after handling. Contaminated work clothing must not be allowed out of the workplace. Wear protective gloves, protective clothing, eye protection, and face protection.

PHYSICAL AND CHEMICAL HAZARDS: Keep away from heat, sparks, open flames, and hot surfaces. No Smoking. Do not apply on or around electrical wiring. Do not apply to hot surfaces or equipment.
