DIRECTIONS FOR USE

Animals, bedding and food may remain on premises during application. Dilute with water or mineral oil at the rate of 1-8 oz per gallon, using the high concentration for severe infestations and low concentration for maintenance applications. For dilution rates and application instructions for specific insects, scan the QR code. Spray to wet treatment area and insects - product must contact and wet insects to be effective. Reapply as often as needed.
