DIRECTIONS FOR USE

Plant Safety: AgForce Total Insect Concentrate has been tested on a wide variety of plants. However, phytotoxicity may vary with specific species and cultivars, and local conditions, tank mixes, and treatment sequences can affect phytotoxicity. Before applying AgForce Total Insect Concentrate, test the product at the intended dilution rate for plant safety on a plant sample or seedling. Do not apply to stressed plants or recently transplanted material before roots are established.

Mixing: Shake AgForce well before mixing. Add AgForce Total Insect Concentrate to water and mix well before applying. Use immediately after mixing (within 8 hours).

For use on fruiting vegetables and non-fruiting vegetables, small fruits, fruit trees, flowering ornamentals, foliage ornamentals, and other food and non-food crops.

Foliar spray rate:
0.6-2.5 fl oz per gallon of water

Dip rate:
0.6 fl. oz per gallon of water

Note: A lower rate is recommended for preventative use, mild infestations, or sensitive foliage while a higher rate is recommended for heavy infestations and larger insects. Treat on a 5-7-day interval.

Spray Application: Add AgForce Total Insect Concentrate to water and mix well before applying, use immediately after mixing (within 8 hours). Using a medium spray nozzle, apply to both sides of leaf, using enough water volume to ensure thorough contact without runoff. Do not apply in rainy or windy conditions and make sure plants are dry within the hour. Exposure to excessive heat, light, and humidity should be avoided after spraying. Apply during cooler hours and when insects are present or shortly before a flight for the best results.

Recommended rates by pest (per 100)	
Mites, thrips, potato capsids, lygus, drosophila, whiteflies and related species	0.6-1.3 fl oz
Aphids	1.3-1.9 fl oz
Armyworms, loopers, cutworms and other caterpillars	1.9-2.6 fl oz

Dip Application: Dilute 0.6 fl oz of concentrate per 4 gallons of water. Dip unrooted cuttings or foliage in solution for 15-30 seconds while agitating. Only prepare enough solution as needed for one day and prepare new solution after dipping plants with pathogen concerns. Test a portion of sample plants for phytotoxicity before dipping the entire sample plant. Avoid dipping stressed plants.
